ORDER :-

1. In the reference 1<sup>st</sup> read above, Director, Handlooms & Textiles and Apparel Export Parks, Andhra Pradesh, Hyderabad has stated that the Additional Development Commissioner for Handlooms, New Delhi has conveyed the sanction in respect of following **03 (Three)** Handloom Clusters under Integrated Handloom Development Scheme (IHDS) during the year 2010-11. The details are as follows:-

2. The Director, Handlooms & Textiles and Apparel Export Parks, Andhra Pradesh, Hyderabad has further stated that as per the sanctions made by the Government of India, the utilization Certificates in GFR-19 (A) have to be submitted to the Development Commissioner for Handlooms, New Delhi within a period of (12) months. Further without submission of the Utilization Certificates, the Development Commissioner for Handlooms, New Delhi will not consider further releases under Integrated Handloom Development Scheme

3. The Director, Handlooms & Textiles and Apparel Export Parks, Andhra Pradesh, Hyderabad has stated that an amount of Rs.4044.09 lakhs is provided in the Budget Estimates 2012-13 under State Plan under the Head 2851-103-06-57-310-312 under the Integrated Handloom Development Scheme (IHDS). The Director, Handlooms & Textiles and Apparel Export Parks, Andhra Pradesh, Hyderabad has requested the Government to sanction and release a total amount of Rs. 54,98,250/- as 2<sup>nd</sup> installment towards Central Share of Grant Component of (3) handloom clusters, i.e., Siddipeta Handloom cluster, Medak, Pochampally Handloom Cluster -I, Nalgonda and Pochampally Handloom Cluster -II, Nalgonda District, under the Integrated Handloom Development Scheme under the Head of Account S.H (57) – Integrated Handloom Development Scheme and to authorize him to draw and disburse the said amount to the concerned Implementing Agencies.

Government, after careful examination of the matter, and keeping in view the Budget Release Order issued by the Finance (Exp.I&C) Department in the reference 2<sup>nd</sup> read above, hereby accord administrative sanction for an amount Rs.54,98,000/- (Rupees Fifty four Lakhs Ninety eight thousand only) towards 2<sup>nd</sup> installment of Central share of grant component of Siddipeta, Medak District, Pochampally- 1 & Pochampally-II, Nalgonda District Handloom Clusters under IHDS during 2010-11, from the Budget provision of 2012-13.

5. The expenditure sanctioned in para (3) above shall be debited to the Head of Account "2851-00-103-10-57-310-312 Integrated Handloom Development Scheme."

6. The Director, Handlooms & Textiles and Apparel Export Parks, Andhra Pradesh, Hyderabad is authorized to draw and disburse the same to the concerned and utilize the funds for the purpose for which they were sanctioned
